**Vendor booth fees** \* Booth spaces are 12' x 12' unless otherwise specified \* Fees are for full weekend (not per day). Fees will not be adjusted if you only attend one day (please see Vendors' Note for details.) Vendors must bring all equipment needed (tent, tables, chairs, tent weights, etc.). Absolutely NO ELECTRIC HEATERS allowed in the park! Every attempt to place vendors in acceptable areas will be made, however in the event of saturated grounds/mud, etc, you should be prepared with wood chips, pine straw, etc. to cover your area; these will not be provided for you.

- Outside (no electricity provided) - \$50 (vendors are allowed to provide their own power via QUIET generators)
- Inside - upstairs only (stair access only - no elevator in the building). \$65 (electrical outlets are available upstairs on a first come basis) [There are NO vendor spaces available on the downstairs floor].
